Dear Parents

**This is a large complex school. A long letter like this one is required to inform you about school matters. Please read it, complete the attached questionnaire, sign it and return the document to the school via your child.**

I would like to take this opportunity to wish you a prosperous 2018. May the relationship between school and home once again be to the best advantage of your child.

A special word of welcome is extended to our Grade 8 learners and their parents/guardians and all new learners in other grades and their families. To all other learners and their parents we say welcome back and we look forward to your support this year.

It is also fitting that we again express our sincere condolences to the family and friends of Zilingene Mazibuko (Grade 12 – 2017) who was tragically killed in a car accident at the beginning of this year.

### **The 2017 Matric Results**

Ladysmith High School congratulates the class of 2017 on their excellent achievement of a 98.17% pass while at the same time honouring all the educators who contributed to their entire school career. We especially thank our staff for the conscientious dedication with which they have prepared these learners for the final NSC examination and their future.

A total of 164 candidates wrote the NSC examination. More than 200 subject distinctions were achieved. A total of 134 learners (83%) qualified for admission to a Bachelor's degree.

I hereby extend my thanks and sincere congratulations to everyone who contributed to our exceptional results; learners, parents and all staff members. True to our motto - Per Ardua Ad Alta – academic heights can only be achieved through hard work.

Such high academic standards are closely related to general school administration, particularly with regards to the maintenance of strict, fair and consistent discipline and this is where we must work together.

While this entails an all-inclusive policy, I would like to highlight the following:

1. **The National Education Policy** prescribes a minimum amount of hours teaching time per week. Consequently all learners must be at school by **7:20** and the school day ends at 14:30.

The school closes at **14:30** on a Friday, but all learners who have worked conscientiously leave at 13:00 (as determined by the Code of Conduct). Learners who are sent to detention for whatever reason, or who did not master or complete specific academic work during the week, will remain at school until 14:30 or later. The entire school will remain, at short notice, until 14:30 on a Friday if there is litter on the school grounds.

If the school closes every week day at 14:30, and at 13:00 on Fridays, we will still have more teaching time over 7 days than that which is prescribed by the department.

2. **At the Annual General Meeting of parents which took place on 28 November 2018, the Resolution was passed that the compulsory school fees for 2018 will be R10 800 per learner.** Our matric results confirm that you definitely get value for your money. Please note the following:
  - 2.1 We can only keep our school fees low if **everyone** who can possibly afford to, pays their school fees.
  - 2.2 If school fees are paid in full by the end of the first term, a discount of R600 per learner is given. Alternatively school fees can be paid in 10 equal instalments of R1080 from 31 January to 31 October. **NB: This concession will automatically fall away if the payment is not made on the prescribed payment day and the full remaining balance will immediately become payable.**

2.3 We wish to remind you that in terms of Section (41) of The South African School's Act 84 of 1996, you are entitled to apply for exemption from the payment of school fees. Should you wish to apply for exemption because you cannot afford the school fees and are able to provide proof of your inability to pay, the necessary Application for Exemption form can be obtained from the school's office. Several parents are assisted in this way. **These applications must be made before the end of February 2018.**

2.4 Please note that the Governing Body has appointed **Mr D Terblanche** as credit controller to deal confidentially with these matters. The Principal is **not** involved with the collection of school fees or the granting of subsidies.

Ladysmith High School would like to make the payment of school fees as convenient as possible. A credit card machine is available at the school. This will help the school and parents by minimizing the use of cash. The machine will accept any master or visa credit or debit cards. The School Governing Body would still prefer payment via bank deposit, debit order or electronic funds transfer (EFT) because then the bank fees can be kept to the minimum.

#### 2.5 **School Books 2018**

We confirm that the purchase of school books remains the responsibility of each parent. NB. **Where the state made a certain financial contribution towards books in a certain grade, this money will be used to the exclusive advantage of all the learners.** Every learner has received a list of stationery for 2018. Any newly prescribed text books are ordered by the school and subject teachers will sell or rent them out in their specific classes. Learners will **not** be allowed to borrow any requirements from other learners. Property must please be **clearly** marked. Parents who cannot **afford** a book or other materials, as in the case of subsidization of school fees, must please address a written and confidential letter to Mr Terblanche for financial help. **No** learner will, because of financial reasons, be excluded from the use of books or other facilities.

The Governing Body has also decided once again, to ask every learner to donate **two reams of photocopy paper** (i.e. two packets of 500 sheets of 80 gr paper) to the school before the end of February.

### 3. The testing and evaluation system for 2018.

During each test cycle tests will take place during the first hour of the day, followed by a break and then the rest of the school day.

**First Term:** Test Cycle: Monday 12 March to Friday 16 March.

**Second Term:** Exams: Monday 11 June to Thursday 21 June.

**Third Term:** Test cycle: Monday 10 September to Friday 14 September  
**AND** Trials: Monday 10 September to Wednesday 26 September.

**Fourth Term:** Exams: Will be communicated to you nearer to the time.  
Grade 12 NSC exams: 15 October – 26 November 2018

### 4. Disciplinary matters

4.1 The Code of Conduct of Ladysmith High School has been revised and rewritten to a large extent in order to streamline the application thereof in practice. The South African School's Act, Act 84 of 1994, as amended, determines that parents, teachers and learners have to be consulted when the Code of Conduct is drawn up or revised. As it entails a substantial document it cannot, therefore, be sent to every parent for this purpose. It is however, available at the school during office hours for your perusal. The Governing Body will approve this during the first meeting in February 2018.

Every learner signed a Code of Ethics and the Addendum to Serious Forms of Misconduct. These undertakings must be strictly adhered to. Copies of these documents are attached.

Some aspects and stipulations are highlighted as follows:

4.2 If a learner does not complete and hand in an assignment which has been set for marks, on a specific day and time, 5% will immediately be subtracted and that same assignment must be handed in on the following day.

4.3 If a learner is sent out of the class because of serious misconduct, the learner **must** appear in the staff room the following morning. If 50% + 1 of the staff members who teach him/her indicates that they also experience serious behavioural problems in their classroom, the parents will be called to school and the learner will be placed under the parent's care for a period of three days in accordance with the principle of "time-out". The idea is that the parent will, on a one to one basis, do the follow-up work at home, so that it is then possible for the **teacher** to continue in the classroom on a one to 35 basis to provide effective education. No learner has the right to deny other learners of **their** constitutional right to education, through bad behaviour.

4.4 If a learner is late (without a valid reason), he/she will have an option of paying a fine of R10 or to sit detention on the first Friday thereafter. Detention will follow automatically on the second transgression and a third transgression will lead to one day "time-out" as well as a warning letter to the parent. A head of department does, however, have the authorisation to listen to the reason given for coming late and to decide whether the punishment is

justified or not. As all gates will be locked at 7:30, learners who are still outside of the school grounds must report to the main gate where their names will be taken and then forwarded to their Grade Heads.

- 4.5 Please **phone** the school if your child is absent from school for **whatever reason**. Furthermore, also write a **letter** of explanation, which your child **must** hand to the register teacher on his/her return to school. An example of such a letter is available from the register teacher. Without this your child will sit detention as punishment. Unfortunately there are learners who will bunk school – often whilst the parents believe that the child is at school. If you do not phone, the Grade Head will have to phone you.

#### 4.6 **General appearance**

The parents of this school voted by an overwhelming majority in favour of a prescribed LHS uniform and a general appearance policy which has been approved by the Governing Body and is applied by the Principal and staff. **Any** deviation from the school uniform rules will **always** lead to conflict, which is really unnecessary. The golden rule is that **no learner may be allowed to get away with breaking school rules, otherwise a thousand other learners also have such a right**. No individual parent necessarily needs to agree with the school rules – yet **legally** you are obliged to ensure that your **child** abides by them. To name a few examples:

4.6.1 There are clear rules laid down with regard to boys' and girls' hairstyles which were finalised after negotiation with the learners as well. These rules will be applied by the school without any further negotiation.

4.6.2 If a learner does not comply with the rules regarding general appearance after being warned, the parent will be telephoned to fetch the learner from the school. This also applies to a boy who comes to school unshaven.

- 4.7 You are reminded of media reports regarding **physical violence and bullying**. The **collapse of discipline** poses a threat to all schools particularly to multi-racial schools. At an assembly, all the learners were warned by means of a yellow and a red card that absolutely **no** form of violence will be tolerated on the school grounds, or whilst wearing **school uniform outside of the school** property. The learner who throws the first punch commits "LHS suicide". Principals have been instructed from the highest level to root out this evil and guilty parties could be expelled. **No learners may take the law into their own hands**. Action will also be taken against learners who provoke others to the extent that violence results. The safety of every learner on this property is the Principal's **first** priority and in this regard he requires the support of every parent.

- 4.8 Lastly, we also require your support to prevent certain prohibited articles from being brought to the school. The Code of Conduct states: A learner of Ladysmith High School "under no circumstances brings onto or uses any **cigarettes** or any other **smoking material, alcoholic drink, drugs,**

**pornographic material** or **dangerous weapons** on the school premises or uses the same whilst dressed in school uniform outside of the school property ...". The Code of Conduct furthermore determines: **"A learner may not use or display a cell phone at school during normal school hours"**.

A learner for example, who brings smoking material to school, will be fined R100. Bringing alcohol or drugs to school will be met without mercy. In some instances where this occurred in the past the result was immediate expulsion.

The capabilities of the modern cell phone are limitless. Learners can convey pornographic material of the worst degree to each other at school, via their cell phones and facebook, for example, which also offer other means of communication. Learners can even be in communication with each other whilst in the classroom. Staff could be totally unaware of this. Learners can photograph events inside the classroom, and post this on facebook and thereby seriously undermine the teacher's professional domain. Any form of cyber misdemeanour will not be tolerated.

The golden rule is therefore that **no** learner may bring a cell phone to school. If a parent requires that a child needs a cell phone for whatever reason, either before or after school, the phone must be handed in during register period in the morning and collected again at the end of the school day.

**5. Grade 8 parents' evening**

All parents of Grade 8 learners and their Grade 8 child/children are cordially invited to a compulsory parents' evening on Monday, 5 February 2018 at 18:00. At this meeting school issues relating to you and your child will be discussed.

**6. Staffing matters**

Three new members of staff, namely Ms C Oelofsen, Ms A Rasool Khan and Ms T Sader have joined us. We welcome them to Ladysmith High School.

**7. Sport:**

Our swimming gala and athletics meeting have been held. Any athletics events which did not take place will be concluded as soon as possible. Trophies for both swimming and athletics will be handed to recipients at a special assembly.

**8. CANSA Relay**

A 12 hour relay in support of fundraising for the CANSA foundation will be held at LHS on 3 March 2018. Teams may consist of 10 or more members. Do keep an eye on the local press for further details and more information is available on the site [www.relayforlife.org.za](http://www.relayforlife.org.za).

**9. School visits by parents**

Parents are reminded that they must follow the protocol if they want to visit the school to discuss school matters. Please make an appointment first with your child's Grade Head. A parent can, thus, not go to his/her child's class (or any other class) unannounced, once he/she has gained access to the school grounds.

Parents should note that such measures exist for the safety of their children and the optimization of teaching time and respect them as such.

**10. School Governing Body election 2018**

The important elections of School Governing Bodies will take place in March 2018. The proposed dates for the election at LHS are Tuesday, 6 March 2018 (first date) and Tuesday, 13 March 2018 (second date).

It is clear that our efforts to keep LHS a winning school are very closely intertwined with **parent involvement and support**. May this support once again be clearly visible in your child's actions, behaviour and progress this year. Ladysmith High School is also determined to remain a values driven school. Every parent, learner and staff member must be aware of the contents of our Code of Conduct. Values contribute to a healthy learning environment which leads to academic success and this in turn develops skills which will be retained for life.
