NOTICE OF NOMINATION AND ELECTION MEETING FOR PARENTS

Notice is hereby given that a meeting for the nomination and election of candidates for the election of 9 parent members of the governing body of the Ladysmith High School will be held on Thursday, 19 March 2015 at 18:30 in the hall of Ladysmith High School.

Candidates, (who must be parents/guardians of learners at the school and who are not employed at the school) may be nominated by submitting to the Principal not more than 7 (seven) days or not less than 24 hours before the nomination meeting, a nomination form, duly completed by the candidate and his/her proposer and seconder. The Electoral Officer will also call for verbal or written nominations during the nomination meeting on 19 March 2015. He will also allow a person who nominated a candidate an opportunity to introduce the candidate to the meeting and give reasons for the nomination or allow a nominated candidate to introduce him or herself to the meeting.

NB: It is the responsibility of parents/guardians to ensure that their names are on the school's admissions register. This register can be viewed at the school as from Thursday, 12 March 2015 until 24 hours before the nomination meeting. This is very important as only parents whose names are on the school's register (i.e. voters' roll) will be entitled to enter the school hall and participate in the governing body election. For this reason you must also please bring proof of identification to the meeting in the form of a South African identity document or a valid passport. Callaway, Principal of Egerton Primary School, has been appointed as our Electoral Officer.

May I also stress the following: For an election to take place a quorum of 15% of the total number of parents eligible to vote must be present. That constitutes some 222 individual parents. If a quorum is not constituted, the meeting must be adjourned to 31 March 2015 when the election will take place irrespective of whether a quorum is constituted or not. It is therefore of paramount importance that parents arrive in numbers at the meeting of 19 March 2015 to elect nine (9) members for the governing body.
